Background 成立背景

环交所作为各类环境权益的价值发现渠道和市场交易枢纽,通过其先进的交易系统、广泛的会员网络与合作伙伴, 将优化节能减排领域的资源配置,降低污染防治的社会成本和交易成本,提高环境治理的效率。环交所以建设资源 节约型、环境友好型社会为己任,通过金融创新推动实现可持续发展。

Chairman's Speech 董事长致辞

2008 年北京奥运会开幕前夕,在国家发改委、 环保部和北京市人民政府及各相关部门的领导下, 北京环境交易所正式挂牌成立。北京环境交易所 肩负的职责和使命,是用市场机制和金融手段推 进节能减排、保护生态环境、应对气候变化。这 既是巨大的挑战,更包含着非凡的历史机遇。

以碳排放权交易和排污权交易等为代表的环境权益交易,在建设生态文明和"美丽中国"的新形势下,是转变发展方式、调整产业结构、完善生态补偿和调节地区差距的重要市场工具,也是治理雾霾等污染问题、改善环境质量的长效机制。环境权益交易与各种创新金融手段结合所形成的环境金融市场,还可以发展成为低碳经济融资的重要途径,为推动绿色产业成长提供必不可少的金融支持,也为金融市场开辟新的增长空间。

近年来,北京环境交易所团队在碳排放权交易、排污权交易、节能服务与合同能源管理项目投融资、低碳转型咨询服务等领域进行了大量创新探索,积极参与国内多层次的环境权益市场建设,为传播低碳发展理念、推进市场机制建设,做出了独特的贡献。目前,北京环境交易所已经发展成为国内最重要和运作最规范的环境交易所之一。随着京津沪渝粤鄂深七省市碳交易试点工作的推进和全国碳排放权交易体系的正式启动,建设中国碳交易市场的机会之门已经打开,北京环境交易所团队将继续秉持创新进取、行稳致远的精神,扎实推进北京市碳交易试点,积极参与国家碳市场建设,努力将北京建设成为国内外有影响力的环境权益交易中心。

On the eve of the 2008 Beijing Olympic Games, China Beijing Environment Exchange (CBEEX) was founded with the joint support from National Development and Reform Commission, Ministry of Environmental Protection, Beijing municipal government and related departments. The core mission and responsibility of CBEEX is to facilitate energy saving and emissions reduction, protect ecoenvironment and address climate change with market mechanism and financial instruments. This task is not only a huge challenge, but also one embedded with historical opportunities.

In the new circumstances of promoting ecological progress and building "Beautiful China", environmental equity exchange represented by carbon emission and pollution trading, is the important market tool of changing the growth model, adjusting the industrial structure, improving ecological compensation and promoting balanced development, and also the long-term mechanism of solving air pollution problems and ameliorating environment quality. market construction actively, advocates the low carbon development concept and promotes market mechanism establishment. This makes CBEEX one of the most important environmental exchanges in China. With the development of pilot carbon emissions trading schemes at Beijing, Tianjin, Shanghai, Chongqing, Guangdong, Hubei and Shenzhen, and the formal initiation of the national carbon trading system, the gateway of opportunities to build China's carbon market is opened. CBEEX will uphold its steady and ambitious spirit with relentless pursuit of innovation to take solid steps in promoting the Beijing pilot emissions trading scheme, and will participate in the construction of nation-wide carbon trading center actively. We are committed to build Beijing market an influential environmental equity exchange center both domestically and internationally.

As an open, fair and just market platform, CBEEX is dedicated to provide professional trading support services to stakeholders including global and domestic emitters, carbon funds, DOEs and consultancy firms, financial institutions, etc. We are committed to support the fundamental construction including energy saving and emissions reduction, environmental protection and urban & rural integrating development for China and Beijing with market tools. We also strive to become the professional platform of international cooperation and capacity building to address climate change, to become the cornerstone of the global environmental finance market, and to contribute our share to the Beijing factor market and infrastructure construction of a "World City".


