Information related to the harmonization following the merger of Powernext into EEX

Dear trading participants,

The European Energy Exchange (EEX) has successfully integrated Powernext and Gaspoint Nordic as of 1 January 2020. EEX is now introducing further technical changes. Those changes are reflecting the new legal set up.

The changes comprise in particular the following elements:

- Harmonization of product long name designation
- Update of BOM Cascading File
- Harmonization of Trading Calendar
- Admission and Customer Care

Additionally, hourly products of NCG L Elten will be renamed into NCG L West, and NCG L Vreden into NCG L East.

Harmonization of product long name designation

Product long names of all EEX natural gas futures and spot market products will be harmonized in respect of an aligned designation of all products.

These changes relate to all maturities. Product codes stay unchanged.

In addition to the harmonization of names, there is an upcoming name change on the hourly products NCG Elten and Vreden. On 1 April 2020 NCG L Elten will be NCG L West and NCG L Vreden will be NCG L East. The resulting name change on the hourly EEX gas spot products takes place in the frontend Trayport Global Vision 31 March 2020 at 14:00 CET.

Impact on technical setup for trading on member side

- Members, who use Joule Direct and Gold mapping service provided by Trayport:
 - Trayport will ensure mapping of renamed gas futures, options and NCG hourly products at Elten and Vreden on member side
 - Please restart Joule front end when the change is propagated (from 23:00 CET on 16/03, 23/03 and 31/03)
- Members, who use Joule Direct <u>but not</u> Gold mapping service provided by Trayport:
 - Member themselves will ensure mapping of renamed gas futures, options and NCG hourly products at Elten and Vreden. The change of name will be possible after 14:00 CET on 16 March for NCG hourly products at Elten and Vreden. A mapping file is attached with all information on the spot products.
 - Members using internal systems should adapt them if they use products names rather than product IDs. If product IDs are used, no change needs to be implemented.
 - Contact Trayport for information and assistance during the configuration and mapping process

EEX and ECC will update Contract Specifications, Clearing Specifications and further relevant documents and publish the updated versions on EEX and ECC websites.

Changes of central parameters in backend trading systems

The technical configuration of T7 will be changed as follows. The target date of this change is 23 March 2020.


Changes in Trayport Joule frontend


The Broker Code and Venue will be adapted to reflect the merger of Powernext and EEX.



EEX Gas products in will no longer be listed in Trayport Joule frontend as PEGAS, instead EEX will be shown in the product name after the name of the hub. Example: TTF Hi Cal 51.6 PEGAS \rightarrow TTF Hi Cal 51.6 EEX

Order input examples on specific products before and after the changes:







While these changes will affect the EEX specific orderbooks, the Joule "stacks", where you have prices from all your mapped venues, will remain as it is. *Example: TTF Hi Cal 51.6**

The above-mentioned changes will be implemented from 22 March 2020 at 23:00 CET – propagation will be done gradually throughout the night and will require a restart of your Joule frontend.

As a Joule user please also pay attention to the below consequence of the name changes:

- EEX gas products must to be re-added to your Marketsheet
- Default Trading Account Options: must be selected again after the name changes
- Product filtering must be done with EEX and not PEGAS
- If you use Market Maker, you must add EEX Gas products again to your market making window

Changes in Trayport Global Vision frontend

In Global Vision frontend GV EEX Gas spot products will not change. *Example: TTF*

Changes in gas trade files

The exchange name in your gas trade files will be updated to match the integration. The product names of all contracts in T7 will be harmonized as follows. The target date of this change is 23 March 2020.

This change relates to gas trade files made available through the web-interface at https://backoffice-members.powernext.com/ and the back-office SFTP.

Update of BOM Cascading File

The former BOM Cascading files of EEX and Powernext will be merged to one EEX BOM Cascading file. A test file can be obtained on demand. The target date of this change is 1 April 2020.

Harmonization of Trading Calendars

EEX will change its trading calendar for the EEX Gas Derivatives Contracts during the course of 2020. Hence, the following current bank holidays will become normal business days, offering trading from 08:00 to 18:00 CET.

- Early May Bank Holiday 8 May 2020
- Spring bank holiday 25 May 2020
- Summer bank holiday 31 August 2020
- Boxing Day (substitute day) 28 December 2020

Envisaged Technical Updates later in 2020

The following elements are planned to change by mid-2020. A separate customer information will be sent in due time.

- Update of SMSS Product Group Names and Reports including adaptation of Elten/Vreden
- Name change of spot trade file FTP
- Adjustment of SMSS Limit Definitions
- Update of CEGH and PXE Member Trade files
